What data do we collect?

- Personal identification information (Full name, email address, phone number, postal address.)

How do we collect your data?

You directly provide The Freeman of Hale with the data we collect. We collect data and process data when you:

- Voluntarily contact us or provide feedback on any of our message boards or via email.

How will we use your data?

We collect your data so that we can:

- Process your order, manage your account.
- Contact you with updates on events and services.

The Freeman of Hale will not share your data with anyone else.

How do we store your data?

The Freeman of Hale securely store your data on a secure server at wix.com, on the Clerk's computer hard drive and may also store your data in hard copy at the Clerk's office

What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request copies of your personal data.

The right to rectification - You have the right to request that we correct any information you believe is inaccurate. You also have the right to request us to complete information you believe is incomplete.

The right to erasure - You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that The Freeman restrict the

processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to The Freeman's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that The Freeman transfer the data that we have collected to another organization, or directly to you, under certain conditions.
